NEED HELP APPLYING FOR AHCCCS?

- ▶ A SAGE Counseling representative is ready to help you through the AHCCCS application process, step-by-step
- ▶ AHCCCS eligibility can be quickly verified through a review of your household income

AMERICAN RESCUE PLAN ACT (ARPA)

- ▶ Temporary funding is currently available to MCAO clients enrolled in a Diversion program, which offers:
 - ▶ No cost for the initial comprehensive assessment
 - ▶ Potential discount of 75%, 50%, 25% or 0% for treatment services, based solely on financial eligibility
 - ▶ No cost for prescribed drug monitoring, as applicable
- ▶ Residents outside of Maricopa County who are receiving treatment from a third-party provider may receive a 50% discount for the monthly Case Coordination Fee, based on financial eligibility

WHAT TO EXPECT

ASSESSMENT & TREATMENT

- ▶ Initial comprehensive assessment
- ▶ Group therapy sessions 1 - 3x per week
- ▶ Random drug monitoring through an external vendor, as applicable
- ▶ Scheduled meetings with your assigned Case Manager
- ▶ Certificate of completion provided upon graduation!
